China and India also clash over another border region, Aksai Chin. Aksai Chin is actually a remote, inhospitable region where mainly nomadic tribes roam, the area was ignored until the 1950s when China built a military road through it to connect Tibet with China, India was angry upon discovery of the road and it ended up becoming a major factor in Sino-Indian Border conflict of 1962. At the end, China took control over 14,700

sq miles of territory in Aksai Chin. China has also claimed islands in the South China Sea in fact, China has taken to dredging the sea and building out inhabited islands such as Woody island or the Spratly islands to tighten its control over the region. Six countries Taiwan, Philippines, Vietnam, Brunei, Malaysia and China hold separate territorial sometimes overlying assert over the South China Sea driven on a number of historical facts and geography. Next is Taiwan which was part of China, it wants Taiwan back because of Nationalism and last is Hong Kong. China wants control over these 6 countries and make them a part of China and expanding its territory.

OBJECTIVE OF RESEARCH

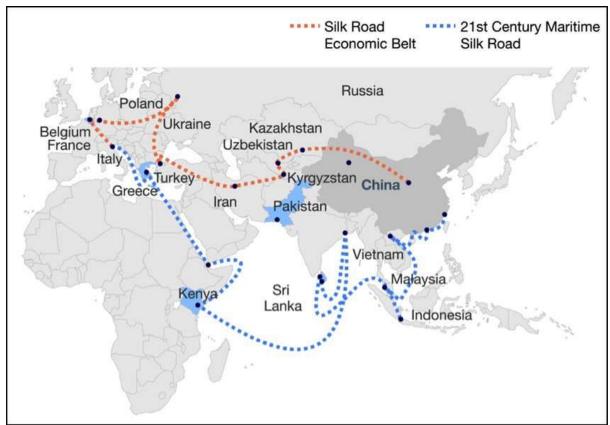
In this Research paper the main area of studies include

The BRI also encompasses oil refineries, industrial parks, power plants, mines and fiberoptic networks all fabricated to make it easier for the world to merchandise with China, so far 60 countries have favourably signed agreement for these projects and the list is increasing because China encourages it as a winwin for everyone .Pakistan saw its highest GDP growth in 8 years and shaped a strong coordination with major world power. China, on the hand assured a new substitute way out for goods, particularly, oil and gas from

Middle East, through projects like these, it also originated a path to amplify its economy. Chinese construction companies that hardly had any opportunities within their own country saw a massive elevation from BRI contacts-7 out of the 10 biggest construction companies in the world are now Chinese. For example in Pakistan, Chinese workers have directly construct highways, Chinese people has assigned with locals on a railway here in Serbia. China's participation is one of its very few demands and that set these projects apart so far. To get financing from the west, countries have to several restriction but China provides billions of dollars mostly in loans with lesser conditions. China is seen as flexible, China's BRI has been a big blow with the less-democratic nations in the region. China has signed agreements with Authoritarian governments, military regimes and some of the most corrupt countries in the world with the aim to dominate the global trade.

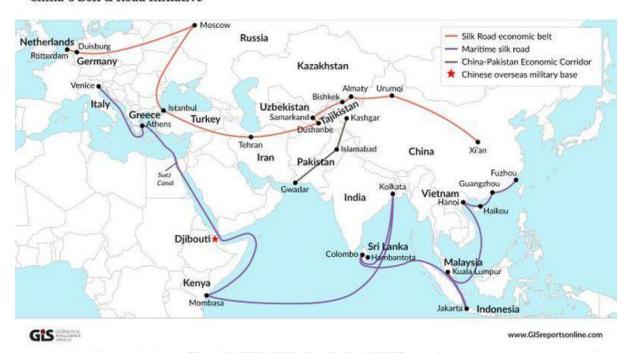


FINDINGS

China's Belt and Road Initiative could be the next risk to the global Financial risk , eventually these countries will have to pay China back-but deception and schism make that payback uncertain , a report found that many countries indebted to China are impuissant , including 8 that are at a high risk of being unable to pay , still China keeps on lending as there is more to the BRI apart from economics , In Sri Lanka China loaned about 1.5 Billion dollars for a new deep-water harbour for the maritime port .However by 2017 it was cleared that Sri Lanka was unable pay back the loan , so instead they gave China to administer the port for 99 years in lease . China also administers the strategic port in Pakistan-where it has 40 year lease , its temptation for similar agreement in Myanmar and the inauguration of an actual Chinese naval base in Djibouti , these all signs of what we call String of Pearls theory .China is trying to create a strong naval bases in the Indian Ocean that will allow it to depot ships and protect shipping routes that move through the area , so while China is not getting its money back

, it is still attaining some very important prudent positions, China's increasing dominance defies the status of US which has been the world's alone super power for the last several decades. Isolation in trending in the US means its investing less and therefore losing ascendancy across the world. The BRI is China's way of gripping power to become a global leader, by building and attaining control of global trade, China is well on its way.

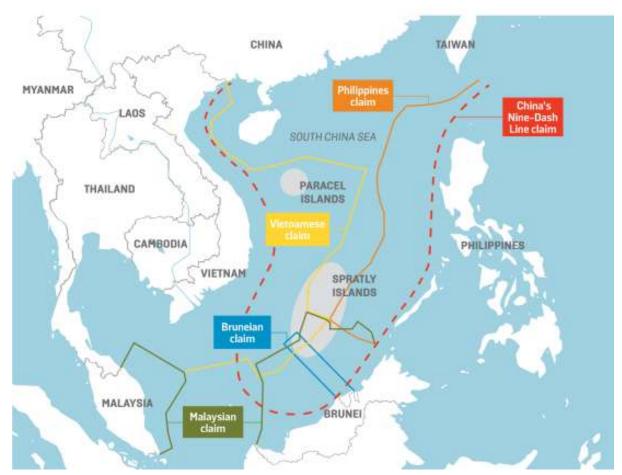
China's Belt & Road Initiative



All South Asia countries are upset about China's all dam projects, China's mega project that will reshape the entire geopolitical environmental-economic landscape of a large chuck of South East Asia using a bunch of dams and strong arm politics. The Mekong river also called the Lancang River in China, it starts from Tibet and flows down through Myanmar, Laos, Thailand, Cambodia and finally Vietnam where it enters South China Sea. Chinese Communist Party feels that it has the strongest right to control the river, because China is the most upstream country which gives it the terrain advantage and also because China is bigger and stronger than those other five little countries combined. China has already built 7 hydropower dams like one along the river Mekong, it has planned to built 21 dams more, it is a concern for downstream countries because dams upstream mess up the entire river natural cycles and that affects the whole ecosystem. The Mekong river is a huge economic resource for the region, Its home to one of the world's most sundry fisheries, after Brazil's Amazon Rainforest, over 60 million people in the lower Mekong river basin rely on the river for food, transportation and water. China's dams are causing some serious dam problems for instance in summer of 2016, South East Asia faced the worst drought in 100 years, it has the biggest impact in Vietnam which directly affected half a million households causing serious problems like lack of drinking water, food shortage and forced internal migration to urban areas.

South China Sea is opulent in oil and gas, there are loads of fish and the shipping lanes are some of the busiest in the world. China wants to dominate it. China says it will reduce differences and dispute through negotiations and the other countries say there have right over it too. Americans they have trade routes through there worth 100 billion dollars. The US has been committed to the idea of freedom of the seas, South China Sea is under the larger ultimatum than no other. China has been a overland power for a long time so its never had much

naval forces . Philippine officials said only a handful of Chinese vessels remained in the area as of April 13. US-Philippines security joint military training exercise resumes, there is an increase in dispute, China and US both have send warships into disputed waters as tension rise over

Whitsun Reef. Tensions spike in South China Sea, China stakes claim over 90% of South China Sea. India 55% of the trade passes through the South China Sea, India and China are having border dispute even during the time of COVID-19 pandemic which has made the situation worst along with South China Sea, Today no country support China, moreover India is not part of the BRI.
