**ANNOTATION**

This article refers to the need to work separately with adolescents, educate them on the psychological side, who have a tendency to prevent, criminalize crimes committed today.

**Key words: criminal people, behavior, adolescent, predisposition to crime, personality psychology**

When everybody listens about a criminal person, it is understood that before the eyes of each person there are people who have committed a crime or have a predisposition to a crime. The word “Crimean” is derived from Latin and means “criminal” – “jinoiy”. Criminal entities can also be divided into two categories; these are people who have committed a crime and are prone to crime. These two groups also have their own distinct differences. Individuals with a tendency to the crime, these are mainly children of adolescent age, manifested in the form of hiccups and cases of aggressiveness to the ears. When it comes to the psychology of individuals who have committed a crime, the state of aggressiveness is now replaced by an obsession, in which various pathological disorders occur in their psyche. For this reason, it is difficult to correct violations in the psychology of those who have committed crimes, and today a great deal of confidence is paid to work with individuals who have a greater tendency to crime and to quench their predisposition to the crime in them. Most of the individuals with a predisposition to crime are children of adolescent age. At schools, the attention paid to identifying the predisposition to crime in adolescent children and eliminating such negative situations in them is becoming more and more today. Naturally, such a question arises in our souls; Why in the same period can a child touch on a crime? The reason for this is simple at first glance, because at exactly this age they are experiencing one of the most extreme crises that they have encountered in their lives. One of the main causes of the teenage age crisis is the imbalance between the awakening of a sense of size in it and the continuation of the relationship of its surrounding relatives to it, as if it were still a child with a fur coat. This in turn leads to various emotional tension in the child, while emotional tension in the teenager is manifested by his behavior in relation to the external environment. And this situation is a relationship of negativity treatment, like laziness, familiar to many of us. There are many reasons that make the adolescence turn into a crisis period (the sexual maturity of children, the appearance and development of a sense of size in them, the need for independence, etc.). It is possible to write a number of articles, brochures devoted to the analysis of such causes. However, some parents who can not find the necessary words to the heart of their children, who are suffering from psychological communication with them, is more interested in how s/he should behave in such situations, what can be done, the reasons for the miscarriages in their children. Do not confuse the crisis in adolescents with spoilage of behavior! Causes of confusion of behavior of children:

Relationship between friends, wrong attitude in the family, imitation of strangers, inability to get out of the crisis. If they are not separated, it can lead to serious problems, because it is understood that the attitude of adolescents towards treatment in the crisis period is deviant, and if they are rebuked at every step by criticizing the adolescent-age student, then there will be negative consequences. After such a relationship, the child becomes afraid of insecurity in himself, making independent decisions and expressing his own opinion. The first appearance of a predisposition to crime in children of adolescent age begins with a violation of the behavior, which many do not pay attention to.

If the predisposition to a crime of teenage age is left without validity, then later it becomes a crime. Even the majority of children prone to crime are deviant children. Deviant soy derived from Latin stranglehold means “deviant” – “deviation”. Deviant behavior is the deviation from the rights and moral values accepted in a particular society. Deviant behavior derives a tendency to crime as an initial part of the chain, which in turn continues the reaction of the chain into a crime. So how do we proceed to take on the future crimes? The work we have always carried out in this regard is the cooperation of this school and parents. Sometimes we avoid the original essence of the problem and, as a result, we turn it into a positive solution to the problem. We must first develop an action program for ourselves, based on the needs of children, in order to break off the above (chain) reaction. To do this, we must first find answers to the following questions:

- 1) What is needed for him during this period that is his primary needs
- 2) what he or she is interested in
- 3) to determine who he likes or imitates

Here is the answer to these three questions cannot always be asked by himself, so we need to know by looking at his behavior. Any teenagers are looking for the easiest and most effective ways to achieve what he or she aspires to. That mechanism is able to perform a specific key function for us. It is necessary for parents to be able to influence this very process. In order for them to reach their intended goals, they need to show the way to the crack based on their needs. Sometimes it is also permissible to awaken positive deceptive intimidation in adolescents, so that this work can be done.

Especially it is necessary to communicate with children of teenage age and go to work with them regularly. Another complex aspect of the issue is that in the same period of time, the crisis in them should not be confused with the confusion of the behavior. Communicating with them during this period is the solution to any problem that may occur in them. It was written that, ” From the art of communicating with the child – I also like complex art” - the famous Polish pediatrician and pedagogue Yanush Korchak.

Disputes arising between the parents and the children in the period of teenager are caused by the following:

- 1) failure to perform various tasks enamored household chores, quarreling with brothers and sisters.
- 2) open manifestation of disrespect towards parents and representatives of the older generation.
- 3) the child is mistaken in the choice of a friend and a partner.
- 4) dress up and make extraordinary alterations in the external imagination.
- 5) going to a lot of different places and events as well as staying away from these places

Again, in criminal or offender persons there is such a situation: - this situation is when an offender or offender has committed a negative act in which these processes are carried out in an incomprehensible state. Such a situation in it is studied in a timely manner, and if it is not immediately corrected, the attitude to the situation will again be realized in similar situations that will occur in the future when it will move to the subconscious. In the study of the psychology of a person again faced such a situation that if a man once again committed a crime the reasons for his origin and all the changes in the psyche of this person are not corrected in time this situation occurs for the second time. The reason for this situation is that his attitude towards this situation when he moves to the underground sphere of consciousness and again falls into such a situation, the attitude towards this situation is carried out unconsciously. His appearance as if he had no other measure than this act is the main reason for his first offense. For the second time, a protective reflex occurs in a person who has committed a crime. This reflex can also be called a state of hypocrisy. Its essence is this: individuals who have formed such a reflex, they are very polite and complementary attitude towards those around them in order to hide their goals from the outside world. His original intention arises only when he falls into a state of

unconsciousness. In order for such cases not to arise, any crime must be eliminated immediately before it is committed.
